AMENDMENT #1 TO GENERAL ASBESTOS LITIGATION CASE MANAGEMENT ORDER OF JULY 8, 2022

The General Asbestos Litigation Case Management Order of July 8, 2022 ("Asbestos CMO") is hereby amended as follows.

A. The Telephone Number for the Judicial Assistant in Department 15

The Judicial Assistant in Department 15 may be reached by calling 213-310-7015. (This amends the telephone number stated in Section D of the Asbestos CMO at page 3, line 24.)

B. Former Testimony Page-Line Designations and Related Submissions

Subsection 4, found at page 16, line 27 through page 17, line 20 of Section P of the Asbestos CMO is amended (replaced) as follows:

4. Final Submission

At least four days before the FSC, the designating party must lodge with the court via USB drive:

(a) Index of Former Testimony Witnesses

The Index shall substantially conform to the form attached hereto as Exhibit G-1 and G-2.

(b) Ruling Template for Each Tier One Transcript

The proponent of the Tier One designation shall be responsible for creating the Ruling Template and submitting it to the court. Each transcript shall have one consolidated Ruling Template that includes all designations, all counter-designations, and all objections (including those of multiple objecting parties) to the transcript. The Ruling Template shall substantially conform to the form attached hereto as Exhibit G-3 and G-4. The Ruling Template shall be prepared in Word® or Adobe® format. If in Adobe® format, the PDF should not be password protected or have any security settings that prevent the PDF from being edited.

The proponent of the designation shall place the fully-marked transcript in the same file folder as the Ruling Template on the USB drive.

The court wishes to receive only the final Ruling Template and relevant transcripts for all Tier One page-line designations. (The court will make further orders concerning Tiers Two and Three designations at the FSC or otherwise.) The prior practice of sequential submissions of "updated" or "corrected" USB drive submissions is strongly discouraged. The parties may update the court at the FSC of any change in the parties remaining active in the litigation and the effect on the designations.
