Mediation Volunteer Panel (MVP)
Mediator Profiles - Sorted by Last Name**

Cases referred to the MVP program are eligible for three hours of virtual mediation at no cost, conducted by a qualified, impartial mediator who volunteers their preparation time and the first three hours of the mediation session. After the initial three hours, if the parties agree to continue, the mediator may charge the hourly rate listed in their profile.

Upon receiving the Notice of Referral to the Mediation Volunteer Panel from the ADR Office, the parties must mutually agree to select a mediator and inform the ADR Office or request that the ADR Office assign a mediator.

- **If selecting a mediator**, the plaintiff or plaintiff's counsel is responsible for contacting the preferred mediator to confirm their availability to conduct the mediation by the completion date. Mediators may accept or decline cases at their discretion. Once an available mediator has been selected, the plaintiff or plaintiff's counsel must provide the mediator's name to the ADR Office using the [online Response Form](#).

- **If requesting mediator assignment**, ADR staff will review the Civil Case Cover Sheet Case Type and assign a mediator with availability to conduct the mediation by the completion date.
