

Notice of Intent

Public notice is hereby given that it is the intent of the Superior Court of California, County of Los Angeles to transfer all or part of the \$1,082,771.21, which is on deposit in the Court's General Trust accounts, to the Court. Authority to process this transfer is pursuant to Section 68084.1 of the California Government Code. This amount includes payments made during the 1960s, 1970s, and 1980s, which have not been fully disbursed or refunded within at least three (3) years. Due to the age of these deposits, specific case information is incomplete or unavailable to support the purpose and intent of the Unclaimed Property Law (Code Civ. Proc., § 1500 et seq.) which does not apply to the funds proposed to be transferred to the Court (Code Civ. Pro., § 1502(a)(3)).

The claim must include the claimant's name, address, amount of claim, the grounds on which claim is founded, and any other information required by the Court. The court will determine if any or part of the specific deposit is still due or may reduce the amount to be refunded. Any of these deposits not successfully claimed by January 26, 2026, shall become the property of the Court pursuant Government Code Section 68084.1 and will be transferred to the Court's Trial Court Operations Fund.
