Older (legacy) cases are marked with a starred folder icon to denote that documents are not available in electronic format. Clicking the case number for a legacy case will open a new popup window containing the case information.

Cases are available on this web site only after they have been entered into the Court's case management databases. Occasionally, entries may not be made immediately after a case is filed.

In compliance with Code of Civil Procedure 1161.2, Unlawful Detainer case information is not available to the public for the first 60 days after filing. For cases filed after January 1, 2004, this section further requires that the case remain unavailable in the event any defendant prevails during this 60-day period.

The search result might contain records of different people of the same name, and it may not contain records of the person for whom you are searching.

FEE SCHEDULE - As offered in the Court's public website, users will now be able to search for public cases by party or company name in the Attorney Portal. Users will be charged based on the same fee schedule used in the public website.

The system will maintain a running count of the number of searches you have submitted for the calendar month commencing the date of your first transaction during the calendar month. On the first day of each month, the counter will be reset. The fee is charged for each search performed, regardless of the number of results returned, if any.
