Log in to the Unicorn Digital Courtroom Application

For the best meeting experience, please download the LACourt Connect Desktop app on your device. Once installed, follow these steps:

- 1. Open the app and select Proceed Remote Participant
- 2. Enter your email and password and click Sign In
- 3. Once logged, the Virtual Gallery will appear

#### **Best Practice:** Use computer audio when connecting. Do not use both video and dial-in simultaneously.

# Calendar (Hearings)

The My Calendar tab shows the calendar and the court hearings scheduled for the selected date. There are two tabs, **Home** and **My Calendar**.

The Home tab shows hearing(s) for the day. If the hearing has not started, you will see the Not in Session notice. If a hearing is active, the **Join Now** button will be activated.



The My Calendar tab shows hearing(s) for the day, ability to search for a hearing, and view future hearings. Selecting a hearing will display a green **Join Hearing** button if the hearing is active.



- 1. Search for a case by number or name
- 2. Select the date from the calendar
- See all hearings scheduled on the selected date
