

### Ways to Connect to LACourtConnect 3.0

### **Quick Reference Guide**

**LACourtConnect (LACC)** is part of the Court's Access LACourt | Your Way initiative and provides a convenient option for appearing in court without having to visit a court location.

This Quick Reference Guide (QRG) outlines the technical specification for using LACourtConnect 3.0. LACourtConnect 3.0 launches using the Microsoft Teams application. You may download the Teams application to your computer or phone to join the hearing. If you are unable to download the application, you may join using the browser version of Microsoft Teams.

## **Computer Technical Specifications**

For the best connection experience, it is recommended remote participants connect via a computer. Following are technical specifications for using Microsoft Teams on a Windows or Mac computer:



Windows

**Computer & Processer:** Minimum 1.1 GHz or faster, two core

Memory: 4.0 GB RAM

Hard Disk: 3.0 GB of available disk space

Display: 1024 x 768 screen resolution

**Operating System:** Windows 11, Windows 10 (excluding Windows 10 LTSC for Teams desktop app), Windows 10 on ARM, Windows 8.1, Windows Server 2019, Windows Server 2016, Windows Server 2012 R2.

**Devices:** Standard laptop camera, microphone, and speakers

#### Video calls and meetings:

- Requires two-core processor.
- Background video effects require Windows 10 or a processor with AVX2 instruction set.
- Joining a meeting using proximity detection in Microsoft Teams Rooms requires Bluetooth LE. Bluetooth LE on Windows requires Bluetooth to be enabled on the client device and requires the 64-bit version of the Teams client. This feature isn't available on 32-bit Teams clients.

Memory: 4.0 GB RAM

Hard Disk: 1.5 GB of available disk space

Display: 1280 x 800 screen resolution

**Operating System:** One of the three most recent versions of macOS. You can find information about the latest macOS versions, and how to upgrade your version of macOS

Video: Compatible webcam

**Voice:** Compatible microphone and speakers, headset with microphone, or equivalent device

### **Browser Application**

LACourtConnect 3.0 is available via an online browser and is recommended for users attending the virtual meeting on an older device that does not support the desktop application and/or users who are in an environment with minimal background noise.
